

# Notes recorded from a document held at Hanbury. Dated 1829

## **Shrawley School House**

Indenture made 22<sup>nd</sup> Feb 12<sup>th</sup> year of William 111 1699 between Alan Cliffe the elder of Astley County of Worcester Esq Lord of the Manor of Shrawley and Allan Cliffe the younger of Astley Gent son and heir apparent of Mr A Cliffe Sen. of one part and Edward Burlton Clerk Rector of Shrawley, Allan Cliffe of Mathon Gent, Thomas Seaverne of Cockbaylis in Shrawley and Edward Seaverne his son, Thomas Seaverne of the other house in Shrawley and Robert Seaverne his son, Thomas Smith, William Randle, John Tolly, Thomas Stone, and Richard Stone his son, all of Shrawley aforesaid feoffees or Trustees of the Messuages tenements and premises with the appurtenances hereinafter granted to and for the benefit of the Church, Parish and Poor of Shrawley of the other part. Whereas an ancient Messuage, Tenement and School House was lately standing and being become very ruinous and likely to fall they the said Edward Burlton (and others) by and with the consent of the Lord of the Manor of Shrawley and other the Parishioners and inhabitants of the said parish have caused the said Messuage Tenement Dwelling House and School House . Now in the lieu place and stead thereof have with the moneys belonging to the said Parish and Poor of Shrawley erected built and set up one other Messuage ,Tenement Dwelling house and School house Now to the intent and purpose that the rents issues and profits of the said new erected Messuage etc may be continually had taken etc to and for the use and benefit of the Church ,Parish and Poor of Shrawley Witnesseth by the said Allan Cliffe Sen and Allan Cliffe Jun. Have aliened granted etc to the said Edward Burlton and their heirs All that the aforesaid new erected messuage etc together with the soil and ground whereon the same is built and the Reversion etc is all the right etc of the said Allan Cliffe and Allan Cliffe Jun in law or equity ,To have and to hold the said messuage etc to the said Edward Burlton (etc) his heirs and assigns for ever witnessed etc in them the said Edward Burlton (etc) reposed that is to say that they Edward Burlton (etc) to their heirs and assigns shall and will from henceforth continually imploy bestow and dispose of the rents profits (etc) of all and singular the premises herein before granted for the use and benefit of the Church, Parish and Poor of Shrawley And the said Edward Burlton (etc) Trustees for the purpose aforesaid and every of them severally and particularly for him and his heirs and executors, admins, and assigns do covenant and promise (etc) to and with the said Allan Cliffe and Allan Cliffe (etc) that they the said Edward Burlton (etc) shall and will well and truly accord to their several powers and authority perform the said Trust (etc) And it is hereby assented and agreed unto by and between the said parties (etc) that it may and shall be lawful for the said Allan Cliffe and all and every other person or persons who shall at any time hereafter be seized of the said Manor or Lordship to have the use and benefit of the said School House to hold and keep this their Court and Courts for the said Manor of Shrawley when and as often as there shall be occasion anything herein contained etc
